January 19, 2018	2:00-4:00pm	2015 International Building Code (IBC) and the 2015 International Fire Code (IFC)
January 20, 2018	10:00am-12:00pm	open discussion on all of the codes
and	2:00-4:00pm	open discussion on all of the codes
